



# ADVERTISEMENT FOR EMPANELMENT OF DETECTIVE AGENCIES

West Bengal Gramin invites applications from reputed experienced Bank and Detective/Investigation Agencies for empanelment to undertake assignments such as to strengthen loan recovery efforts by locating borrowers, co-borrowers, guarantors, mortgagors, and their legal heirs (whether in India or abroad) who are untraceable or unavailable at recorded addresses and by gathering updated information on their present whereabouts, occupations, income sources, businesses, assets, bank accounts, and borrowings from other institutions. The agencies will also confirm the current ownership status of secured assets, provide market-based valuation updates, and collect information not accessible through normal channels, thereby supplementing the efforts of field officials and enabling more effective recovery of the Bank's dues.

#### **Eligibility:**

- 1. Detective Agencies with **at least 3 years of relevant experience**, adequate resources, financial soundness, and proven competence will be eligible for engagement.
- Preference will be given to agencies empanelled with Sponsor bank (PNB) or engaged by at least two reputed banks (one being a public sector bank) and preferably members of the Association of Private Detectives & Investigators (APDI).
- 3. Agencies must maintain strong business reputation, compliance culture, and ethical standards, ensure police verification of employees, and strictly adhere to laws, RBI/Fair Practices Code, and Bank's guidelines without resorting to coercive or unlawful methods. Agencies blacklisted by any Bank/FI/Govt. body need not apply.
